PRE-BALLOT NOTICE OF ANNUAL MEETING & ELECTION OF DIRECTORS

Dear Homeowner:

You are cordially invited to the Annual Meeting of the Membership and Election of Directors for the Glen Towers Owners Association, which will be held at **10:00am** on Sunday, **September 21, 2025**. This meeting will be held virtually via Zoom, and the in-person address for the meeting is 1333 S. Beverly Glen Blvd. Los Angeles. Location: Pool Room. The PURPOSE of the meeting is to elect THREE (3) members to the Association's Board of Directors by Secret Ballot at this meeting. THREE (3) directors will be elected for a TWO (2) year term.

We will be determining our election of THREE (3) directors by counting Secret Ballots at this meeting. The Association's Bylaws Article 3.6 states a quorum is a majority of the voting power. WE MUST RECEIVE A QUORUM OF BALLOTS IN ORDER TO OPEN AND COUNT THE BALLOTS. Please be sure to send in your Ballot as soon as possible to help achieve a quorum. Each Owner is entitled to the number of votes listed in Exhibit "C" of the Association's CC&Rs. A ballot which casts more than the number of votes an Owner is entitled to will be disqualified.

Quorum requirements are:

- 1st Attempt = 51% Quorum (25 ballots)
- 2nd Attempt via CA Statutory Reduced Quorum (Civ. Code § 5115) = 20% Quorum (17 ballots)
 - Adjournment to use 20% Quorum <u>must</u> be approved by Association at prior meeting
