### Quorum requirements are:

- 1<sup>st</sup> Attempt = 50% Quorum (8 ballots)
- 2<sup>nd</sup> Attempt via CA Statutory Reduced Quorum (Civ. Code § 5115) = 20% Quorum (3 ballots)
  - o Adjournment to use 20% Quorum <u>must</u> be approved by Association at prior meeting if it is not stated in the governing documents.
